EXECUTIVE SUMMARY

We received 120 responses to this consultation. 98 percent of respondents were members of the public. When asked about what they wanted to comment on, 79 percent chose to comment on polling districts and places under assessment, versus those not under assessment. The most selected polling place was Henley Leisure Centre - 29 percent selected this.

Below is a summary of the results relating to each polling place under assessment for which responses were submitted.

- **Goring Village Hall:** 11 respondents commented on this polling place. No clear majority emerged in support or in disagreement with the proposal to remove the reference to 'Belleme Room' from the polling place. However, more respondents agreed with it (45 per cent), than disagreed (27 percent).
- **Stadhampton Village Hall:** 83 percent disagreed with the proposal to move the polling place from Stadhampton Village Hall to other venue not yet identified. Among the alternative venues that were suggested by respondents, Stadhampton Village School was the most mentioned one.
- Henley Leisure Centre: 20 respondents commented on this polling place. 70 percent said they prefer Henley Town Hall, rather than Christ Church Centre, as alternative polling place for district LIA 2 Henley North. For polling district LIA4 Henley South, 58 percent disagreed with the proposal to move the polling place to Sacred Heart Parish Church. Among the alternative polling places suggested by respondents, Valley Road School and Scout Hut on Greys Road were the most mentioned.
- **Shiplake Scout Hut.** One respondent commented on this polling place. They strongly agreed with the proposal to move the polling place to Shiplake Memorial Hall.
- **Watlington:** One respondent commented on this polling place, and they strongly disagreed with the proposal to move the polling place from the Fox & Hounds Public House to Watlington Parish Office. They also disagreed with the proposal to merge the two polling districts, LOH1 and LOH2.
- Watlington Parish Office: Two respondents commented on this polling place. No clear majority emerged on the proposal to merge polling districts LOH1 and LOH2. Watlington Bowls Club was ranked 1st among the alternative venues that could replace Watlington Parish Office as a polling place, and respondents suggested Watlington Library as an alternative venue.
- Stoke Row Village Hall: Two respondents commented on this polling place. No clear majority emerged on the proposal to move the polling place for LPC voters to Rotherfield Greys Village Hall.
- **The Crown, South Moreton:** Nine respondents commented on this polling place. 78 per cent strongly disagreed with the proposal to move the polling place to North Moreton Village Hall. South Moreton School was suggested as an alternative venue.



- Ladygrove Community Centre: Two respondents commented on this polling place. No clear majority emerged with respect to the proposal to split polling district RBA1 into two smaller districts. Willbrook Leisure Centre was suggested as an alternative polling place.
- **Didcot Civic Hall:** Nine respondents commented on this polling place. 56 percent agreed to split polling district RCA2 into two smaller ones. There was no clear majority with respect to the proposal to move the polling place to Edmund's Park Pavilion. However, more respondents disagreed with this proposal (33 percent), than agreed with it (22 percent). No clear majority emerged on the proposal to move the polling place to GWP Southern Community Centre. However, more respondents agreed with this proposal (44 per cent), than disagreed with it (22 per cent).
- Northbourne Centre: Four respondents commented on this polling place. No clear majority emerged with respect to the proposal to move the polling place for district RCA3 to King Alfred Drive Community Centre. However, more respondents agreed with this (50 per cent), than disagreed (25 percent). On the second proposal, to move the polling place for district RDB to Didcot Methodist Church, no clear majority emerged.
- 2nd Wallingford Scout Group, Station Field: Ten respondents commented on this
 polling place. No clear majority emerged on the proposal to replace the 2nd Wallingford
 Scout Group as a polling place, however, more respondents strongly disagreed with it
 (50 percent), than agreed (30 percent). Respondents made various suggestions of
 alternative polling places: Hithercroft Sports Ground, Wallingford School and Guides Hut
 and Fir Tree School.
- St Mary's Church, Market Place: 13 respondents commented on this polling place. No clear majority emerged on the proposal to move this polling place in Wallingford to Centre 70. Respondents suggested various alternative venues: the Baptist Church, Wallingford School Main Hall or Sports Hall.

No respondents commented on the following polling places:

ENGAGEMENT METHODOLOGY

The 'South Oxfordshire Polling Districts and Places Review Consultation' was launched on 13 September and closed at 11.59pm on 25 October 2024. The consultation was open for six weeks.

The consultation was advertised to the public and local representatives by:

- Posting on social media platforms (Facebook, Instagram, Twitter and Nextdoor) on 13 September, and multiple times over the weeks that followed. Posts on Facebooks and Instagram received 5,114 views and 65 clicks, whilst posts on Nextdoor and Twitter were viewed by 3,600 and 182 users respectively.
- Publishing an article on 'In-Focus' on Thursday 12 September. This newsletter is sent to the district's town and parish councillors, and to district councillors.
- Publishing a joint press release on Friday 13 September, to provide information on the reviews undertaken by both South Oxfordshire and the Vale of White Horse district councils.
- Emailing parish clerks and district councillors on 16 September to renew the invitation to respond to the consultation, and to ask them to advertise it locally by displaying a poster with QR code and link to the consultation in their village notice boards.
- Emailing local political parties and MPs on 20 September.
- > Publishing an article on 'South and Vale News' on Thursday 3 October.

Reporting methodology

This report provides a summary of all quantitative and qualitative results of this consultation.

When stating percentages in the analysis, we are referring to the percentage of respondents that answered the specific question, rather than the total number of responses to the overall survey. Response percentages may not add up to 100 percent due to rounding up over .5 and rounding down under .5. Words that appear in italics are quotes taken from comments received.

A full list of all comments made in relation to each question is also available in this report. Any personal information supplied to us within the comments that could identify anyone has been redacted and will not be shared or published. Further information on data protection is available in our <u>general consultation's privacy statement</u>.

Some punctual errors in the original comments raised were corrected in the main body of this report.


KEY FINDINGS – QUANTITATIVE AND QUALITATIVE DATA





Q5. If you want, you can use the text box below to comment on any of the above polling places, for example to highlight issues or make suggestions based on your voting experience. Please make sure you mention the specific location(s) you are commenting on.

This section of the survey provided the opportunity to comment on any of the polling places or districts which were not under assessment. A full list of places and districts not under assessment was shown at the beginning of the page.

We received 17 comments in response to this question. Below is a summary of what respondents said and a table with the full list of redacted comments.



LAD – St Laurence Hall, Warborough: Two respondents said they are happy with this polling place.

LKA - Goring Heath Parish Hall: One respondent said they are happy with the venue and the location.

RAC1 and RAC2 – Stewart Hall, Brightwell cum Sotwell: Two respondents complained about the lack of a polling place in Shellingford Hill, noting that the polling place in Brightwell-cum-Sotwell is far and not served by public transport.

LEJ - Beckley & Stowood Village Hall: One respondent said they are happy with this venue and location.

LFB - Garsington Village Hall: One respondent reported issues with accessibility at this polling place and suggested moving it to Denton Lane Sports and Social Club.

LIA1- Henley on Thames Town Hall: One respondent reported accessibility issues at this venue. Another respondent expressed disagreement with the proposal to move the polling place to Walton Avenue.

LIA5 – Sacred Heart Parish Church, Henley on Themes: One respondent said they are happy about this venue and location.

RBB - Fleetmeadow Community Centre: One respondent said this is a good location. Another one said that this venue is accessible but not well sign posted.

LGA2 - Goring Village Hall: One respondent suggested moving the polling place to Goring and District Community Centre.

Impossible to do so unless you have a car, and all the roads in the village are single track, so it's a very difficult

Q6. How far do you agree or disagree with the proposal to move the polling place from Waterperry Gardens Limited to Holton Village Hall?


There were no responses to this question.

Goring Village Hall

Q8. How far do you agree or disagree with the proposal to remove the reference to a specific room (Belleme Room) which can be used a polling place inside Goring Village Hall?

There were 11 responses to this question.

No clear majority emerged in either support of, or disagreement with the proposal to remove the reference to a specific room within the polling place (Belleme Room). In fact, although data shows that just under half of respondents agreed with the proposal (45 percent), including nine percent who strongly agreed with it, 27 percent disagreed (including nine percent who strongly disagreed), and another 27 percent neither agreed nor disagreed.

However, overall, more respondents agreed with this proposal (45 per cent), than disagreed with it (27 per cent).

Eight further comments were made. Five of them suggested replacing the existing polling place with the Goring and District Community Centre on Station Road. Three respondents



highlighted accessibility issues with the existing polling place, whilst two supported the proposal to remove the reference to 'Belleme Room.'

ANON-Q4K2-GT3U-5	It's the same building and is always appropriately signposted, not everyone recognises the room name
ANON-Q4K2-GTCP-G	I have no objection to which room, as long as the polling station remains within the Goring Village Hall.
ANON-Q4K2-GT86-B	Polling should be moved from Goring village hall to the Goring and District Community Centre, Old School, Station Road, Goring RG8 9HB. This is more central to the polling area. The front (main) entrance will shortly face on to a new pedestrian priority lane in Station Road. It has an accessible entrance and accessible lavatory and has ample car parking for staff and voters that does not, unlike at Goring village hall, tend to obstruct the pavement, making it difficult for people with impaired mobility to enter or pass by. The Community Centre has good, direct pedestrian and wheelchair / mobility scooter / pushchair access, through the Arcade, to and from High Street, close to the shops. This latter point will encourage rather than discourage participation in elections by Goring residents.
ANON-Q4K2-GT8F-U	Acess for the disabled is not d Good enough
ANON-Q4K2-GTF8-U	If possible, polling should be moved from Goring Village Hall to the Goring and District Community Centre, Old School, Station Road, Goring RG8 9HB. Advantages to the voting public are easy access from anywhere in the polling area (access to the front of the building from Station Road and to the rear of the building via the Arcade); ample parking for voters (useful for voters who don't like to walk in the rain); easy access for wheelchairs and mobility scooters; large rooms which can be configured for maximum voter privacy.
ANON-Q4K2-GTFB-5	I think that the Village Hall generally is not suitable at all, due mainly to the fact that it is difficult for disabled voters to gain access. There is not sufficient parking close enough. I think that a better place would be the Goring Community Centre in Station Road. It has plenty of parking, is very accessible from the centre of the village with disabled access straight from the car park. There is a kitchen and toilets for use of the staff on voting days.
ANON-Q4K2-GTF3-P	It has been suggested that it might be better to use the Community Centre, Station Road, Goring RG8 9HB for the polling station. It has access for the disabled and car parking for both voters and staff. It is also in a more central location in the village and houses the offices of Goring on Thames Parish Council. Its location near the shops in Goring will encourage people to vote.




ANON-Q4K2-GTF4-Q I propose the use of the Goring and Streatley Community Centre in Station Rd, Goring as it is right in the middle of the village. There is parking at the back which can be used together with disabled access. There is plenty of room for the voting booths and volunteers. Toilets an a kitchen again for volunteers use.

Stadhampton Village Hall

Q10. How far do you agree or disagree with the proposal to find an alternative venue to replace Stadhampton Village Hall as a polling place?

Due to Stadhampton Village Hall having accessibility issues, the polling districts and places review suggested to find an alternative venue to use as a polling place. Most respondents disagreed with this proposal (83 percent), including 50 per cent who strongly disagreed.

A minority of respondents agreed with this proposal (eight percent), and another eight percent neither agreed nor disagreed.

Q11. If you can suggest any venues in the local area that could replace Stadhampton Village Hall as a polling place, please use the box below to let us know.

We received seven responses to this question. Here are the venues that respondents suggested:

- Stadhampton Village School (x3).
- Stadhampton Pavilion (x1).
- St Katherine's Church (x1).

One respondent said they disapprove of the primary school being used as a polling station to replace Stadhampton Village Hall. Below is the full list of comments.

Henley Leisure Centre


Q15. Please rank the alternative venues we have identified for LIA2 Henley 2 (North) in order of preference, with 1 being your favourite venue, and 2 being your least preferred one.

Due to the existing polling place for LIA2 Henley 2 North having accessibility issues, the elections team have identified alternative venues that could be used during elections. We asked respondents to rank the two alternative venues according to their preference.

We received 20 responses to this question.

A majority of respondents said they prefer the Town Hall as alternative venue to replace the existing polling place. In fact, 70 percent ranked this venue first, whilst Christ Church Centre was ranked first by the remaining 30 percent of respondents.

We received 15 additional comments. Almost all comments expressed disagreement with the proposal to move away from Henley Leisure Centre, which respondents would like to retain as a polling place. Many comments highlighted insufficient parking at the alternative venues under consideration.

Below if a full list of all redacted comments.

ID	Response
ANON-Q4K2-GTCF-6	I do not understand why you wish to move away from the existing Henley Leisure Centre for our Polling station as it is very convient being just out of the town centre with plenty of parking spaces. None of your proposed alternatives meet either criteria. Whether you like it or not a majority of voters arrive by car. The Town Hall is in the centre of the town and really unable to cope with any more voters on the day. People park in the disabled parking spaces or on the double yellow lines, some on the pavement! Very few use the Greys Road caprpark and walk over - too lazy??? To try and get in to the Christchurch centre carpark is asking for trouble as it is on the main Reading road and is a very small, conjested carpark.
ANON-Q4K2-GTGD- 8	Can't see what's wrong with Henley Leisure Centre. An easy walk for most.
ANON-Q4K2-GTGG- B	The leisure centre is perfect. Please leave it. There is parking, which encourages some voters, and it has a very smooth operation. Don't fix something that doesn't need fixing.




ANON-Q4K2-GTG4- R	Personally, I actually believe the leisure centre is a perfect location! It will alienate a lot of voters from the top of Henley as the parking at the Christchurch centre is very limited and traffic thst side of town is terrible on a quiet day! Plus the town hall houses so many voters and parking in town is mostly terrible too!
ANON-Q4K2-GTGR- P	Please retain Henley Leisure Centre as a polling station to support accessibility to residents in the Gillotts area who already face limitations such as lack of shops
ANON-Q4K2-GTG8- V	Parking could be an issue since a lot of people drove to vote at the Leisure Centre and there isn't any parking dedicated to either venue
ANON-Q4K2-GTGZ- X	I am of (as far as I can tell) of normal hearing for my age. This polling station is to my mind NOT excessively noisy. It is easy to access via the 3 footpaths, has reasonable parking, and serviced by the Henley Hopper. The alternates offered are approximately 1 mile away and probably around 300-400 ft vertical Hight difference. (Greys Hill), Considering many of my neighbours are closer to 80 than any other decade, it would be a strong disincentive to vote. It is almost gerrymandering in my humble opinion.
ANON-Q4K2-GTGJ-E	Both of these alternatives are.not viable for my family and many of our elderly and less able neighbours. The current option (Henley Leisure Centre) has ample parking unlike the Town Hall and is much more accessible for the many elderly people living on Makins, Blandy, Wootton Roads. The Town Hall would meant more people being forced into the town centre which already struggles for parking on a quiet day. On polling day, many people would be left unable to vote due to the lack of parking. Both alternative options are at the buttom of the hill and therefore inaccessible for those less able living at the top of the hill.
ANON-Q4K2-GT1D-J	Leisure centre works fine as is and is perfectly accessible to all
ANON-Q4K2-GT1B- G	I have voted in Henley Leisure Centre for 10 years and cannot understand why it might be 'too noisy'! Noisy for whom? In my experience the voters are normally well behaved and the Leisure Centre itself doesn't seem 'noisy'! The parking is good and there is a local bus service that makes it easy to get to if you haven't got a car.
ANON-Q4K2-GT1P-X	No preference, fail to see how either would be quieter than use of the segregated areas within Henley leisure centre that is currently used. Physical access is worse at the town hall. Both are significantly further than current station. Parking is worse at both proposals.
ANON-Q4K2-GT1Q- Y	I think this proposal is wrong. I have worked as a poll clerk at Henley Leisure Centre, it is ideal, many people walk there as they live nearby, there is no problem with noise and there is plenty of parking. We should not be putting polling stations away from the area they serve, we should encourage people to vote. This proposal will deter people from voting.



ANON-Q4K2-GT88-D	The leisure centre does seem to be a better venue, for accessibility and parking.
ANON-Q4K2-GT84-9	The leisure centre is more convenient for me
ANON-Q4K2-GTMH- J	The Christchurch Centre does not seem suitable as there is very little parking. This is also major problem for the Town hall, and is of concern for older voters. I would have thought that leaving the polling both at Henley Leisure Centre would be the best solution for this polling district, and just moving the LIA4 - Henley 4 (south) to a different location.

Polling district LIA4 Henley South shares the same polling place, Henley Leisure Centre, with LIA2 Henley 2 North. The elections team have identified the Sacred Heart Parish Church as an alternative polling place for this polling district and have asked respondents for their views on this proposal.

Most respondents disagreed with the proposal to move the polling place for LIA4 from Henley Leisure Centre to the Sacred Heart Parish Church (58 percent). This includes 54 percent who strongly disagreed.

28 percent agreed with this proposal, including 21 percent who strongly agreed, and 14 percent neither agreed nor disagreed.

We received 18 further comments. Of them, eight comments highlighted accessibility issues at the Sacred Heart Parish Church. Six comments expressed disagreement with the proposal to move away from Henley Leisure Centre. Two expressed positive comments about the Sacred Heart Parish Church, whilst one expressed negative feelings about the existing polling place (Henley Leisure Centre).











Another 25 per cent of respondents neither agreed nor disagreed with the proposal.


No additional comments were made by respondents.

We received four responses relating to district RDB. No clear majority emerged among respondents, which either supported or disagreed with this proposal. 
Q56. How far do you agree or disagree with the proposal to find an alternative venue to replace the 2nd Wallingford Scout Group as a polling place?

The existing polling place is no longer suitable due the size of the electorate and because it has limited facilities. The elections team has therefore proposed to find an alternative venue to replace the 2nd Wallingford Scout Group as a polling place.

There were ten responses to this question. No clear majority emerged among respondents which either supported or disagreed with the proposal. More specifically, whilst 30 per cent agreed with it, 50 per cent strongly disagreed and 20 per cent neither agreed nor disagreed.

However, more respondents strongly disagreed with this proposal (50 percent), than agreed with it (30 percent).


The existing polling place of St Mary's Church in Wallingford is no longer suitable due to lack of sufficient space for the size of the electorate, and limited parking. The elections team proposed to move the polling place to Centre 70 or other alternative venue.

Q59. How far do you agree or disagree with the proposal to move the polling place from St Mary's Church to Centre 70?

There were 13 responses to this question. No clear majority emerged among respondents which either supported or disagreed with the proposal. More specifically, whilst 31 per cent strongly agreed with it, an equal number of respondents disagreed, including 23 per cent who strongly disagreed. An additional 39 per cent of respondents neither agreed nor disagreed with it.

Respondents made ten additional comments. Three comments highlighted limited parking at the proposed venue of Centre 70. Two comments expressed positive feelings about moving the polling place to Centre 70, whilst another two indicated that they prefer St Mary's Church. Two comments said that using a church as a polling place is inappropriate.






117 out of 120 respondents answered this question.

Overall, more females than males took part to this consultation. In fact, whilst female respondents made up 59 percent of the total, male ones made up 33 percent. Nine percent of respondents preferred not to answer this question.

This result is quite different from real population data for South Oxfordshire, where females make up 50.7 percent of total population, and males 49.3 percent.


There were 117 responses to this question.


92 percent of respondents said that the gender they identify with is the same as their sex registered at birth. This is very close to the figure for the real population, which is 95 percent.

One percent said their gender is different from the sex registered at birth, which is somewhat higher than the figure registered within the real population -0.13 percent. Eight percent of respondents preferred not to say.




The largest age groups to respond to the consultation were the over 75s and 55-64-year-olds, which made up 20 percent of total respondents each. This was followed by the 65-74 and 45-54-year-olds, which made up 18 and 17 percent respectively.

Together, three age groups made up the majority of all respondents. These were the over 75s, 65-74 and 45-54-year-olds, which made up 58 per cent of the total. These groups also responded in much larger proportions when compared to younger cohorts and to their shares of the district's population (please see chart above).

35-44 and 25-34-year-olds made up 13 and six percent of total respondents respectively. These proportions are very close to their shares of the district's population.

Younger cohorts appear to be underrepresented in this consultation by comparison with real population data, particularly the under-16s.



Q65. What is your ethnic group?

89 percent of respondents said they are White – English, Welsh, Scottish, Northern Irish or British. This compares to 86 percent of district's residents who belong to this ethnic group.

Four percent said they have 'Any other White background'. This is similar to population data, where people with 'Any other White background' make up six per cent of the total.

The two White groups above were both well represented in this consultation.

One percent said they are 'Gypsy or Irish Traveller'. This group's share of total population is 0.1 per cent.

Seven per cent preferred not to answer this question.





Q66. Do you have any physical or mental health conditions or illness lasting or expecting to last 12 months or more?




118 out of 120 respondents answered this question.

13 percent preferred not to answer this question.




Q39. Do any of your conditions or illnesses reduce your ability to carry out day to day activities?

HOW WE HAVE USED RESULTS OF THE CONSULTATION

Thank you for taking part in our consultation on South Oxfordshire Polling Districts and Places Review. As a local authority, it is our statutory duty to review polling districts and places for UK parliamentary constituencies at least once every five years. Your feedback has been reviewed and helped us shape our final proposals, which have been presented to the Community Governance and Electoral Issues Committee (hereafter 'the Committee') on 18 November 2024.

On 18 November 2024 the Committee discussed and agreed to all the changes to polling districts and places which were included in our <u>final recommendation</u>. All the proposals initially made in this consultation have been adopted, with the exception of:

- Polling district LEG Waterperry with Thomley: Waterperry Gardens Limited will remain the designated polling place for this district.
- Polling district LGA2 Goring-on-Thames: the Committee designated Goring Community Centre as the polling place for this district, thus replacing Goring Village Hall.
- Polling district LHF Stadhampton: Stadhampton Village Hall will remain the designated polling place for this district.
- Polling district LIA2 Henley (North): Henley Leisure Centre will remain the designated polling place for this district.
- Polling district LIA4 Henley 4 (South): Henley Leisure Centre will remain the designated polling place for this district.
- Polling district LPC Highmoor: Stoke Row Village Hall will remain the designated polling place for this district.
- Polling district RAH South Moreton: The Crown Public House will remain the designated polling place for this district.
- Polling district RFA1 Wallingford No.1: The Wallingford Scout Group will remain the designated polling place for this district.
- Polling district RFA2 Wallingford No.2: This district has been split into two smaller ones, RFA2 and RFA3. The designated polling place for RFA2 is St Mary's Church, whilst for RFA3 is Centre 70.

You can read the agenda and the minutes of the Committee's meeting on our website.

Following the meeting on 18 November, the Elections team has proceeded to implement the agreed changes. This required updating and publishing the electoral register to include the amendment of polling districts, which took place on 16 December 2024, and updating the list of default polling places on the election management system shortly afterwards. All listed changes were actioned to take effect before the next election in May 2025.
